(*local time*) on Tuesday, August 12, 2014. Immediately thereafter, the bids will be publicly opened and read aloud in the Conference Room of the Concord Regional Airport.

All bids will be awarded by the Concord City Council. If applicable, the bidder shall have a City of Concord Privilege License prior to award of bid.

No bid may be withdrawn for a period of ninety (90) days after the closing time for the receipt of bids. The City of Concord reserves the right to reject any and all bids and to waive any and all technical defects in the execution of the submission of any bid.
